The following categories of students will be eligible to appear in SSC 02nd Annual Examination 2022: -

- All the registered candidates of SSC I & II up to March, 2022 (Regular/Ex/Private) whose admission form was cancelled/not submitted for SSC 1st Annual Examination 2022, due to any reason are eligible to apply for SSC 02nd Annual Examination 2022.
- All those registered candidates of SSC I & II up to March, 2022 who has submitted their admission form for SSC 1st Annual Examination 2022 but remained full absent in SSC 1st Annual Examination 2022 for any reason are eligible to apply for SSC 02nd Annual Examination 2022.
- The candidates who intend to improve their Grade/Marks after passing SSC Examination can do so by re-appearing in any number of subjects/papers of their choice of Part-I or Part-II or both the Parts/entire examination. The candidates appearing in any subject (both the papers) involving practical examination shall appear in the practical examination as well. However, candidate neither requires nor can appear in practical if he/she is appearing in a paper of a subject or any one part of the examination.
- IBCC candidates are eligible to appear in SSC 2nd Annual Examination 2022.
- Passed candidates of SSC-I 1st Annual Examination 2022 can appear for improving the marks/grade.
- Compartment candidates of SSC-I are eligible to appear in SSC 2nd Annual Examination 2022
- Change of subjects/group will not be allowed under any circumstances after final submission of online admission form to the FBISE's Office.
- All the Heads of affiliated institutions are requested to ensure that the particulars of candidates on the admission forms are recorded on the basis of registration cards. Online admission form(s) will not be entertained / accepted without registration number(s).

MODE OF SUBMISSION FOR REGULAR CANDIDATES OF SSC-I & II.

Admission data (in soft form) placed on FBISE website for SSC-I & II candidates will be filled in letter and spirit by the institution and submitted online only within specified due dates. **No hard/printed copy of admission form and documents (if any) of SSC-I & II regular candidates shall be sent by institution(s) to FBISE office by post.**

MODE OF SUBMISSION FOR EX/ REGISTERED PRIVATE/IMPROVEMENT/IBCC CANDIDATES.

Admission data (in soft form) placed on FBISE website i.e. www.fbise.edu.pk will be filled in letter and spirit and submitted online by the candidates within given due dates. **No hard/printed copy of admission form and documents (if any) shall be sent by the candidate to FBISE office by post.**

MODE OF REMITTANCE OF FEE

For remittance of fee to the FBISE account, the overseas institution(s)/candidate(s) may exercise one of the following options:-

- i. The payment may be made through Credit Card (Master or Visa) from FBISE website (preferably for quick credit and verification of fee).
- ii. The payment may be made through SWIFT "MT-103" (via Commercial channel instead of home remittance(PRI)) for credit into FBISE Pak Rupee Account Swift Code: HABBPKKA IBAN Code No. PK26HABB 0022 1100 5000 2001 at the Habib Bank Limited, FBISE branch, Sector H-8/4, Islamabad (Pakistan) OR FBISE US dollar account (IBAN) PK 79 HABB 0022 1179 0068 7511 (for US dollar remittance only) at Habib Bank Limited, FBISE Branch, H-8/4, Islamabad (Nature of fee must be mentioned while preparing Swift MT 103 form/text).

Note: **Receipt of deposited fee through MT103 swift message must be enclosed with the online admission form(s).**

- iii. Payment may also be made through **Bank Draft drawn able at Islamabad (Pakistan)** issued in the favour of Secretary, Federal Board of Intermediate & Secondary Education, Islamabad.
- iv. The institutions/candidates forwarding online admission forms from KSA and UAE may remit the dues/examination fee through following banks to HBL, FBISE account:-
