However, Oversees Pakistani/expatriate whose children are studying in various programs of BU, may be exempted from payment of advance tax if they fulfill/provide the following conditions/documents as per Clause 236 (I) of Income Tax Ordinance 2001:

- A copy of passport as an evidence to the Campus that during any tax year, his stay in Pakistan was less than one hundred eighty-two days
- A certificate on proper legal paper that he has no Pakistani source of income
- Transactional proof that the fee is remitted directly from aboard through normal Banking channels to bank account of the BU
